Working Group Vision Statements

The following statements were developed by sixteen working groups:

1. Citizens of New Lebanon are friendly, hospitable and are not elitist. There is a community center for activities such as dances, cooking classes, book discussions, speakers, etc. There is a diversity of stores large & small (travel agent, coffee shop, bakery, pharmacy, farmers market). Noise ordinance is in effect & enforced, which preserves the tranquility of the valley. There is preservation & expansion of farms. Landscaping of commercial areas & junky areas are cleaned up. There are outdoor concerts in Shatford Park. Many walking trails, multiple use of town park, more conservancy land. Increased districts - Springs, Mt Lebanon, with tours - carefully monitored. There is state of the art electronic communication and community bulletin boards, and good newspaper coverage.

2. New Lebanon is a place where attractive businesses are flourishing & encouraged. They include a drug store, hardware store, farmers market, restaurants & grocery store that are appropriately clustered. In New Lebanon, preservation of open space is a priority & the town is characterized by attractive homes & landscaping, bountiful trees & scenic views & preserved wetlands. Recreation planning is an important town activity and includes the creation & maintenance of running, walking, bike and ski paths and trails. The whole area of New Lebanon is a well known historic attraction where the Shaker Heritage is preserved, where other historical assets are preserved and where cultural attractions like the Theatre Barn are successful. School and library facilities are responsive to the needs of the community. Diversity of community is cherished & preserved, social activities for community interaction is encouraged; everyone has a chance to be heard & share their ideas. Each contributes to the whole. Farming is a valued activity in New Lebanon. Future traffic congestion is minimized & safety is ensured with blinking lights where pedestrians are crossing & at schools.

3. Local businesses that serve local residents, community and tourists of area, with safe streetscapes, pedestrian traffic, vehicle traffic through lighting, sidewalks, etc. Attractive business community centered on village square with adequate parking and pedestrian access. Local government responsive to community needs with community involvement and reasonable enforcement. Involved community of diverse and accepting population, encompassing schools, businesses, farming, all age groups. Blending of recreation, historic and cultural activities, with community access, including full utilization of Town Park. Business & community that respects the environment.

4. Town activities that would bring diverse community residents together. Well-defined business zone, which has good traffic flow, looks good & is separate from residential area. Superior school system that coordinates with the library and cultural activities. A town health and community based home care & pharmacy in town. A community agreed upon zoning code, which is uniformly applied & enforced. Enhance & create activities for recreation & cultural events.

5. Clusters of small businesses & stores that offer a full range of products and services. Safe and scenic bike trails, footpaths & sidewalks. Properties are well maintained. Services and programs to promote tourism. Orderly and safe traffic flow through town to protect citizens. Farming remains a viable economic activity - community programs encourage an appreciation of farming. A variety of cultural and recreational services and programs to promote a sense of community. Maintaining & promoting green space & rural nature of area. Happy, involved citizens working together to make town better.

6. A town that puts people first (diversity, support, volunteerism). Maintained rural character - vibrant & attractive Main Street & green spaces. Town with a smart & coherent growth plan that builds community. Town residents & businesses work together to meet needs of all. Natural beauty is preserved with growth. Good communication between officials & residents. Working towards a healthy environment. Town has a community newsletter/ paper.

7. Respectful involved community that values beauty & environment, no visual distractions from natural beauty,

downtown area is aesthetically pleasing to look at. Develop a plan for maintaining & developing a small business community with clean (computer, etc.) environment supported by the people. Great (off road) flea market that allows selling in a controlled environment. Affordable housing, cluster housing in open areas. Schools state of art, utilized outside school hours. Activities for youth. Well supported library/ many community activities, music & cultural programs advertised and actively supported. Capitalize on Shaker heritage & expansion/ encourage tourism. Preservation of woodlands, wetlands & water resources/ farmland preservation. Welcoming committee - shared, inclusive attitude, involving all residents. Numerous community functions throughout the year/ care of children & the elderly.

8. Preserve & enhance the towns beauty. There are sidewalks to connect commercial uses. Burgeoning & vibrant commercial center. Diversity of housing for all ages & income groups. A variety of environmentally sensitive opportunities for activities like biking, hiking, etc. The town has preserved & enhanced its historic character. The Speedway has been converted to other less intrusive uses like a park. The school system is excellent. There is more ethnic & cultural diversity in the town. There is less government & more incentive for people to be sensitive to the quality of life of the community. There are many more innovative small businesses.

9. The natural beauty of the town is maintained. Good services for health needs. Good municipal services. Appropriate & attractive signage. Community & recreational services available for all age groups. Town is magnet for tourism (cultural, historical). Farming is diverse & in good shape. Diversity of residents that care about each other.

10. New Lebanon is a place where the rural character & natural beauty have been preserved. People & wildlife have access to open space, clean air & clean water. The central commercial area is a pleasant attractive area where people can congregate to talk, eat or shop & which is pedestrian friendly. Cultural & historic sites are valued, preserved and celebrated. The community serves the needs of youth and the elderly. There exists opportunities for outdoor recreation, specifically walking areas for seniors and hiking & biking trails. Public schools and the library are superb. Small town government where everyone's voice is heard.

11. The town promotes a visual image in terms of facades, signage and maintenance of private property that doesn't conflict or detract from the natural beauty. Development of a town center with trees, streets, sidewalks, adequate parking, shops, restaurants with an attractive small town look and feel. A community center for all age groups with appropriate activities and available for social events. Attractive to visitors because of a variety of cultural offerings. Housing that meets a variety of income and lifestyle needs of residents; zoned to provide adequate spacing and environmental preservation. A variety of safe environments for walking, biking, skiing/ safe pedestrian activities. Public services (low cost transportation for elderly, disabled, non drivers). Coordinated services with neighboring towns (libraries, medical, etc.).

12. The town center is attractive to locals & tourists, and provides a vibrant business district with adequate shopping, dining & accommodations. The town center and surrounding roads are tree lined & landscaped, neat & clean and designed to slow traffic without bottlenecks with commercial establishments integrated into environment and thru travelers remark about it favorably. The town promotes its historic, cultural and recreation attractions with pleasing signage and information kiosks at primary entrances. There are well-designed community centers for all ages, recreational facilities and affordable housing for seniors and young people. There are numerous, thriving farms with sufficient profits to allow for attractive farm facilities. There are a variety of educational opportunities for adults and youngsters at the school and library. Citizens take pride in their properties and respect their neighbors.

13. Capitalize on natural beauty, history & location. Created a downtown center that is nicely landscaped and attractive, allowing for socialization, pedestrian accessibility for shopping and gathering. Create community center to provide services and support. Create community that encourages involvement and inspires responsive governance. Develop a plan to provide for affordable housing and cluster development. Utilize town's natural

resources and green spaces to develop and provide recreational opportunities for residents of all ages.

14. New Lebanon will be the “Gateway to the Capital District & the Berkshires”. A safe place to live & work & raise a family. A place where you’ll never feel like an “outsider”. Beauty & history draw people to our town. Encourage development of new & existing businesses.

15. A community center that includes activities for children, government offices, historical society, movies and senior programs in a safe, pedestrian friendly area with activities for teens. A thriving business community which includes a really great grocery store, a pharmacy, many good restaurants, shops that sell crafts inspired by local history, coordinated by a strong, local merchants association. Downtown New Lebanon is characterized by minimal signage, trees & plantings, sidewalks, a park and pedestrian mall, full occupancy of buildings and lots, off-street parking, and fleas market sales controlled by permit to restrict sprawl. Outdoor recreation opportunities include bike trails, town-maintained trailheads to trails connecting to Shaker Mtn. & Pittsfield State Forest. The Town Park & high school sponsor recreation opportunities such as increased town hours at the high school pool & improved tennis courts & playground at Shatford Park. The town encourages tourism by producing a brochure, manning a town visitor center and working closely with Mt. Lebanon Shaker Museum in restoring the Great Barn & North family property.

16. Neighborhood - attractive, well-maintained neighborhoods with sidewalks and tree lined streets. Establish a community feeling of pride. Recreational resources - Healthy outdoor activities in well equipped community facilities for all ages. Business - Attract/ establish community businesses that serve the needs of the residents and visitors. Diverse residents - An involved community of respectful residents from diverse income, educational and cultural backgrounds that welcome visitors. Schools - quality public schools with well funded arts and sports facilities and programs. Landscape - Tree lined streets, gardens and nature walks welcome visitors. Safety - Strong local law enforcement. Heritage preservation - A widely known tourist destination renowned for preserved historic buildings and cultural offerings.

A DRAFT Unified Vision Statement

In the future, our historical and cultural resources, natural beauty and rural character will remain the most prominent features of New Lebanon. Sensible land use regulations control new uses and encourage low impact development that meet the needs of the community, enhances quality of life, and preserves the character and environment of our town. Scenic views, natural resources, rural character and open spaces are maintained. New Lebanon has a strong sense of community where people are friendly, diverse and welcoming, and where there is a high degree of cooperation and communication between citizens and the local government. Quality public services include road improvements, emergency services, recreational and cultural activities, schools and affordable housing. Residential and commercial properties as well as roadways are well kept. Attractive signage invites visitors to our town and sidewalks encourage usage of a well defined town center.

The following statements were developed by four different working groups of participants:

1. A strong merchant association with marketing to grow business. A variety of small business & light industry (pharmacy). Better banking. Several different towns growing produce for area markets & restaurants. Recognizable town center. Highly centralized Aclean@ business center. Infrastructure (sewers, sidewalks, etc.). Pedestrian traffic. Large welcoming signs at all ports of entry. Night street lighting. Business signs are attractive (similar look in town center). Increased year round population. Retain qualified workers after graduation from high school. Schools do more with trades & crafts. Better distribution of tax burden. Tax credits to business. Fair taxes to support services. Taxes cut by 1/3. No large scale businesses here until tax structure gets fixed. Zero unemployment. 24 hour police protection. Zoning laws enforced (derelict properties). Traffic flows slowly & smoothly. Speed limit is slowed to 35 - 45 so businesses can be seen. Some sort of public transportation for elderly & young. Continue Taconic to Route 20.
2. New Lebanon is clean, landscaped, presentable town where zoning laws are enforced. It is pedestrian friendly; lower speed limits are enforced; and travelers are encouraged to go slowly and perhaps stop because of the presence of a local and visible police officer. New Lebanon has a variety of businesses that make it self-sufficient, so that residents and visitors needs can be met. For example, it has a grocery, drug store, hardware store, hotel/ motel, etc. The Town has a recreation center that links the school, teens, seniors, their activities and sports. Residents are able to enjoy our new rail-trail for walks & hiking. The diversity of the community should be encouraged by inclusionary activities that bring in public & private schools, the elderly, native & non-native, part-timers & full-timers.
3. We have a neat looking town with good lighting, sidewalks, streetscaping, open vistas, and farmland. We have a great park for children to play with many functions planned there. We have a newspaper dealing with local news & issues and events and advertising local businesses and tourist destinations. Promotion by Columbia County Chamber of Commerce. Town is hospitable to tourism with a tourist information center, plenty of parking, bed & breakfasts, a winter sports facility, summer attractions, a new hotel, tours by van. There are lots of new, small, attractive businesses including eateries, shopping and senior escort services. There is more industry contributing to the overall business culture accented by manufacturing & technology with expansion of employment opportunities.
4. Our town supports a challenging educational program, offers scholarships, and pursues grant monies. We explore alternative energy options to reduce costs to taxpayers. An improvement in service is the presence of a cell tower. Tourism is promoted at a new Welcome Center, which features the Shakers. Through community planning we have a traffic plan which maintains the character of our town. A business friendly atmosphere is encouraged through the removal of

present obstacles and the offer of incentives.

A Unified Vision Statement (DRAFT)

On December 6, 2002, Karen Ross and Jack Yurish met with the Senior Citizens Group to get their input for the Comprehensive Plan. The meeting took place at the Catholic Church Community Hall on route 20. Approximately 35 participants were in the hall; not all were residents of New Lebanon. Their commentary was as follows:

- **Clean up the place in West Lebanon—the one with the big trailers.**
- **Doesn't seem to be any zoning enforcement.**
- **Don't know how to get the Town to respond to the eyesores.**
- **Nothing for kids to do here—need more recreational activities.**
- **No jobs for kids to want to stay around after graduation.**
- **No police protection.**
- **Used to have tourist booths---left to rot.**
