Supervisor Houghtling received one email and read the following: $Hi\ Tistrya,$

I will not make it to the Town Board meeting Tuesday as I am coming off covid.

However, here are my thoughts on the storage shed moratorium and the Coon waiver request which should be shared with the Board.

Based on discussion at the last Town Board meeting it appears that self-storage sheds will continue to be an allowed use in New Lebanon, but with some specific regulations.

If the Board plans to extend the moratorium for purpose of allowing storage sheds with further regulation development, then please do not grant the Coon moratorium waiver as it was only to avoid being excluded from expanding.

If storage sheds are to be allowed, then Coon should wait for the new improved regulations... more teeth perhaps than the current Site Plan Review regulations which we have found to be difficult to enforce.
