### **INTRODUCTORY LOCAL LAW NO. 9 OF THE YEAR 2023**

### A LOCAL LAW TO AMEND CHAPTER 45 OF THE TOWN CODE OF THE TOWN OF NEW LEBANON, ENTITLED "RECORDS".

#### **SECTION 1**

This local law shall be referred to as "A Local Law to Amend Chapter 45 of the Town Code of the Town of New Lebanon, Entitled 'Records'".

#### **SECTION 2**

Chapter 45 of the Town Code of the Town of New Lebanon, relating to Records, is hereby amended as follows:

A. Paragraph C of Section 45-8 of Article II of Chapter 45 of the Town Code of the Town of New Lebanon is hereby amended to read in its entirety as follows:

> C. The Town of New Lebanon Town Supervisor, 14755 Route 22, New Lebanon, New York 12125 shall determine appeals regarding denial of access to records under the Freedom of Information Law.

### **SECTION 3**

If any word, phrase, sentence, part, section, subsection, or other portion of this Law or any application thereof to any person or circumstance is declared void, unconstitutional, or invalid for any reason, then such word, phrase, sentence, part, section, subsection, or other portion, or the proscribed application thereof, shall be severable, and the remaining provisions of this Law, and all applications thereof, not having been declared void, unconstitutional, or invalid, shall remain in full force and effect.

### **SECTION 4**

This Local Law is enacted pursuant to the New York Municipal Home Rule Law and Article 6 of the New York Public Officers Law.

### **SECTION 5**

This Local Law shall become effective upon the filing of this Local Law with the New York Secretary of State.
