Area Variance for single family home and Gazebo **Property Owner:** Lori Berube and Henry Grossbard

Applicant: Paul Gurda

Paul Gurda gave an in depth description of what the property owners would like to do with the property. Due to a ledge outcropping, the 100' setback from the pond would prevent the proposed house from having a direct view of the pond. Moving it to a spot 50' from the pond would allow for a full view of the pond from the house.

1. Conformity to neighborhood:

The proposed variance will not have an undesirable effect on the neighborhood.

2. Alternative: If the pond is to be seen, there is no alternative to the proposed siting.

- 3. Environmental: No environmental issues were identified.
- 4. Substantiality Due to the lot size and topography, the Board determines that the variance is not substantial.
- 5. Self-created hardship. The request is a self-created hardship, in that the owners knew or should have known of the setback requirements. However, in area variances this is not fatal to the request.

The Board voted unanimously to grant the 50' variance for both the proposed house and Gazebo

Board Member Salem made a motion to approve the request for a 50' variance for the Gazebo and the house. Seconded by Board Member Stoller. the vote carried as follows:
