Agreement for the Expenditure of Highway Moneys

AGREEMENT between the Town Superintendent of the Town of New Lebanon Columbia County, New York, and the undersigned members of the Town Board.

Pursuant to the provisions of Section 284 of the Highway Law, we agree that moneys levied and collected in the Town for the repair and improvement of highways, and received from the State for State Aid for the repair and improvement of highways, shall be expended as follows:

- 1. GENERAL REPAIRS. The sum of \$ 342,225 shall be set aside to be expended for primary work and general repairs upon 45.99 miles of town highways, including sluices, culverts and bridges having a span of less than five feet and boardwalks or renewals thereof.
- 2. PERMANENT IMPROVEMENTS. The following sums shall be set aside to be expended for the permanent improvement of Town highways:

(a) On the road commencing at Cannon rd and leading to Lebanon Cemetery rd, a distance of .33 miles, there shall be expended not over the sum of \$ 65,000

 Subbase remove existing sub base - widen rd to 20' through 75.3 acres with 3' shoulder on each side

(b) On the road commencing at Cemetery rd and leading to Rt 20, a distance of 1.65 miles, there shall be expended not over the sum of \$ 200,000.

 Width of traveled surface 20'  
 Thickness 1.5" of Leveler/shim coat  
 Subbase Cemetery rd - cut shoulders - improve drainage - remove trees where needed - Truck coat rd - 1 1/2" shim coat/leveler to improve water shed on roadway
