PUBLIC COMMENT:

Supervisor Houghtling opened the floor to public comment and asked if there was anyone that wished to speak regarding Introductory Local Law #1 of 2024 or have any comments that they would like to put on the record.

Jim Carroll: Jim stated, he is speaking as a resident not representing the Planning Board nor the ZRC. He would like to encourage the board to accept the Planning Board's recommendations but if it requires delaying a vote beyond tonight's meeting, he would say go with the current regulations but perhaps in six months come back and look at the other recommendation because it will result in a more concise regulation, get rid of redundancy, and will be easier to work with. Jim stated, there is however one thing the board may want to look at now and make a change on. Jim referred to page 11 of the proposed local law, building design:

Building Design. All new buildings and structures shall be designed and constructed so as to be compatible with the neighborhood and in keeping with the design and construction of buildings and structures then existing on the site.

Jim stated, he thinks the intent was that you can either stay with your current design, make it bigger, same building style, color, etc. or you can go with the new regulations. He stated, this compatible with the neighborhood wording has been a thorn in their side with a prior application for storage units, because everyone has a different opinion with what is compatible with the neighborhood. He thinks that wording needs to be removed.

No one else spoke in person on Introductory Local Law #1 of 2024.

Supervisor Houghtling stated that she has not received any emails regarding Introductory Local Law #1 of 2024.
