Concepts

Creighton Manning developed concepts based on 2023 public meetings and survey:

- Sidewalks (stone dust) on both sides (primarily north side, high school, Valley Plaza and library)
- Calmed traffic (narrow pavement width)
- Two **crosswalks** with pedestrian refuge islands
- Maintain Two-Way-Left-Turn-Lane
- Cost \$2.5 million

Walking Paths

- Multiple layers of material to create a durable surface.
- Excavate approximately 12 inches
- Layer of road fabric
- Mixture of coarse sand and crushed stone compacted and graded level
- A top layer of stone dust (a mixture of crushed limestone and fine particles)
- Compact, grade, and crown the stone dust
- Include concrete ramps at intersections and mid-block crossing to meet requirements American Disabilities Act (ADA)

The result will be a hard, smooth, and durable surface with minimal puddles and erosion from stormwater.





NYSDOT Grant


- In 2024 the Town applied to three grant programs:
 - Transportation Alternatives Program (TAP)
 - Congestion Mitigation and Air Quality Improvement (CMAQ) Program
 - Carbon Reduction Program (CRP)
- Awarded CRP grant, approximately \$2.5 million (20% local match and 80% grant)

Project Includes:

- 5-foot-wide, stone dust sidewalk
- Two **pedestrian crossings** with refuge islands
- Narrow pavement to fit sidewalks in NYSDOT right-ofway



Complete Corridor Proposal




- On the north side 4,600feet of sidewalk (Library to High School)
- On the south side, a 1000 feet of sidewalk (Midtown Mall to Roaring 20s)



Concept 5 – Segment B



Mid-block pedestrian crossing could be added at strategic location; would require tapering two-way left turn lane and adding pedestrian refuge island.

Maintenance

- The Town will be responsible for maintenance
- Budget approximately \$8,000/year for shortterm and long-term maintenance.
 - Annual maintenance will cost approximately \$3,200.
 - 10-year maintenance will cost approximately \$50,000.
 - Approximately \$80,000 every ten years.
- Based on similar assumptions this was the lowest cost build option considered (asphalt and concrete) including construction and 20 years of maintenance.



Snow Removal

Local contractor provided rough estimate for these costs:

- Each snowfall up to 4 inches would cost \$400 (assume 4);
- Each snowfall between 4 and 8 inches would cost \$600 (assume 3); and
- Each snowfall over 8 inches would cost \$700 (assume 2).

Annual snow removal cost approximately - \$5,000.






 This trail sees thousands of users per week (bicycles and pedestrians), plus construction traffic


• No maintenance over first couple years



Special Election

- January 21, 2025 from 8:00 AM to 8:00 PM
- Immaculate Conception Meeting Hall, 732 US Highway 20
- All registered voters who are registered to vote in the Town of New Lebanon
 - See handout for information on registering
- Mail in and absentee voting is allowed
 - See handout for information on both
- If the referendum passes:
 - Town Board has approval to move forward with the proposed walking path project; and
 - **Provides the Town with another option for paying** for the Town match



Project Schedule – Next Steps

- Two meetings with same information (12/30/24 and 1/11/25)
- Vote/election (1/21/25)
- If project receives approval– move forward with Locally Administered Federal Aid process
 - Town led with NYSDOT oversight
 - Design (2025/2026)
 - Public involvement (several opportunities throughout 2025 and 2026) to provide input
 - Construction complete (2027)
