ENCUMBER FUNDS FROM 2024 TO 2025 BUDGET  
DECEMBER 30, 2024**

At a year-end meeting of the New Lebanon Town Board, held at the New Lebanon Town Hall, 14755 NYS Route 22, New Lebanon, New York, duly called and held on the 30th day of December, 2024, the following Resolution was proposed and seconded:

***ENCUMBER FUNDS FROM 2024 BUDGET TO 2025 BUDGET***

WHEREAS, the Town of New Lebanon Town Board budgeted to build a BBQ Pit Roof and Walking Bridge in line item A-7110.2 in the 2024 budget; budgeted to renovate the tennis court bathrooms in line item A-7140.42 in the 2024 budget; budgeted to paint the community center in line item A-1520.4A; budgeted to test water in line item A-8710.4A; and budgeted to purchase a leaf blower in line item DA-5130.2A; and

WHEREAS, the Town of New Lebanon Town Board has accepted a quote from Galusha General Contracting for the BBQ Pit Roof, Walking Bridge and Tennis Court Bathrooms; has accepted a quote from Phenomenal finish for painting the community center; has accepted a quote from Capital Region Environmental Lab for water testing; and has accepted a quote from Leonard's for the leaf blower; and

WHEREAS, the Town of New Lebanon has contracted for these services in 2024 and begun these projects in 2024 however the projects will not be completed and paid for until 2025; and

WHEREAS, all of these projects will need to be paid for in 2025 from the money budgeted in the 2024 budget;

NOW, THEREFORE, BE IT RESOLVED, the Town Board of the Town of New Lebanon hereby moves to encumber the remaining balance of line items A-7110.2, A-7110.42, A-1520.4A, A-8710.4A and DA-5130.2A in the 2024 budget into line items A-7110.2, A-7140.42, A-1520.4A, A-8710.4A and DA-5130.2A in the 2025 budget.
